Following previous consultations, Camden Council is proposing to build new, sustainable and fit-for-purpose accommodation for both Abbey Community Centre and Belsize Priory Health Centre.

• This community hub building will provide improved healthcare and community facilities for local residents.

- The proposals include new landscaping, cycle storage, parking improvements and improved recycling and waste facilities.
- Improved road crossing points would be provided to make it safer for pedestrians to reach the new community hub.
- The old community centre and health centre buildings would be demolished to make way for new affordable homes in Phase 3.

# What has changed?

In the previous stage of the design, the health centre and community centre were to be located in two separate buildings.

These buildings (shown on the drawing in yellow) were to be each side of Casterbridge and Snowman towers, adjacent to the foot of each block. Parking spaces would be removed.





## Why has it changed?

The current proposal co-locates the health centre and community centre into one building which is further away from the two towers.

Parking is retained.

A new public open space can be reached through the community centre. Improved landscaping to the rest of the open space includes a new children's play area.
