Dear Somers Town resident,

**Central Somers Town revised proposals  
Have your say - 23 March to 27 April 2015**

We are writing to update you on Council plans to deliver a new Edith Neville school, new community facilities, improved open spaces and new homes in Somers Town. Although Somers Town is under pressure both from HS2 and significant cuts in Central Government funding we now have a revised proposal which includes:

- a new community hub and play project building that remains close to the existing Plot 10 building
- new homes on Brill Place which have moved in order to minimise impact on the park and local residents
- a new park that seeks to better join-up the green spaces at Polygon Road and Purchase Street.

**How can you give your views?**

We want to know what you think about these proposals and there are lots of different ways you can give us your views:

**Exhibition and model of the proposals** – an exhibition with model will be available at Somers Town Community Centre, 150 Ossulston Street from 23 March -27 April 2015 between 9.30am and 5.30pm (and often later) with much more detail about the proposals. Just pop in, have a look and give your comments.

Officers will be present on Tuesdays 24 March and 31 March, from 4pm to 7pm to explain the proposals and answer your questions.

**Talk to the Central Somers Town Design Team** – we will be running a number of pop-up events where you will be able to speak to the team directly – just pop along.
