Supporting children and young people with SEND to learn to travel independently helps them to take part in education, employment and leisure activities in their community

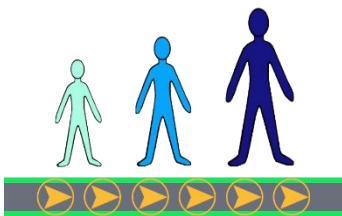
This policy covers travel arrangements for

We want to support children and young people to do be as independent as possible when they grow up

To do this we think most disabled young people should be offered travel training



We know that this will depend on your needs and abilities



Independent travel training would never be done without the agreement of your parents or guardians



We work with families, schools and colleges to find out which children could benefit from travel training



While a child is being assessed for independent travel training and receiving the training, they will continue to get the help with travel that they get at the moment
