#### The purpose of the processing

The London Borough of Camden is collecting contact information and housing information to gather Expressions of Interest from residents wanting to receive a subsidised whole house retrofit plan.

This information will be used to identify and award the subsidised plans to 20 homeowners in Camden. Applications will be assessed based on the location of their homes, property types and the information provided about their retrofit journey to date. Personal information will also be used to contact residents about the outcome of their application.

Once notified, the names and contact information of successful applicants will be shared with our contractors, Ecofurb, who will contact residents to arrange a home survey which will inform the contents of the whole house retrofit plan.

## The legal basis for processing:

Our legal basis for processing is Article 6(1)(a) Consent. The personal data gathered is minimum which is also consistent with the requirement of Article 6(1)(e).

You have the right to withdraw consent at any time if you are no longer interested in receiving a plan and can do this by emailing <u>greencamden@camden.gov.uk</u>.

## The Categories of Personal Data:

Name, address, phone, email, homeownership status and information about resident's housing type.

The categories of recipients that the council has or will disclose the data to.

We will not transfer your Personal Data outside the EU/EEA.

#### The criteria used to decide the retention period

We will keep data collected from the questionnaire for up to seven weeks which is line with the period of time the Expressions of Interest will be open for and the time it will take to evaluate and notify successful applicants.
