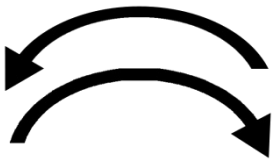
We want to keep the rules we have at the moment about

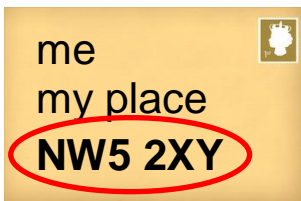

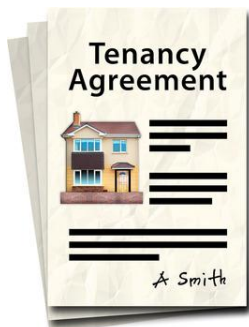

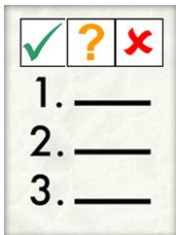
