Camden Council is preparing an Area Action Plan (AAP) for Fitzrovia in response to continued significant pressure for development in the area. We are now seeking your views on a working draft of the Plan.

The Area Action Plan will help to shape the future of Fitzrovia by:

- addressing the impact of growth on residential amenity and the balance between residential, institutional and commercial uses;
- developing a shared direction for the area; and
- coordinating development proposals across a number of significant sites.

We aim to ensure that development proposals bring real benefits to the area, particularly in terms of open space and other public spaces, housing, affordable homes, community facilities and locally produced energy.

Fitzrovia lies between Marylebone and Bloomsbury, straddling the border of the City of Westminster and the London Borough of Camden. The Action Area Plan covers the part of Fitzrovia that lies within the Camden. The eastern part of the area merges with Bloomsbury.

Fitzrovia is an area where an established residential community lives alongside a rich mix of activities including commercial, university and health uses. Our overall vision and objectives for the area address the issues and challenges Fitzrovia faces, respond to its character and context and set our aspirations for future development.

The vision for Fitzrovia is:


A harmonious co-existence of uses and users

To achieve this, we have developed four key objectives:

- addressing the impact of growth on residential amenity and the balance between residential, institutional and commercial uses:
- providing a range of facilities, services and places that sustain and support local resident needs:
- creating a high quality physical environment;
- ensuring an environmentally sustainable future.

In preparing the Fitzrovia Action Plan we have been working closely with a Steering Group made up of representatives of four local community groups, four major landowners in the area and local ward councillors.

Following on from the vision and objectives the working draft of the Area Action Plan:

- sets out 'land-use principles' to provide a Fitzrovia-specific approach to applying our existing LDF policies where this is helpful, e.g. on student housing, shops, food and drink, tourist accommodation and institutions;
- identifies distinct 'character areas' within Fitzrovia with urban design principles to guide development in the light of its specific character, context and setting;
- designates fourteen opportunity sites where development is expected. The land-use and urban design principles are brought together to form a 'mini planning brief' for groupings of adjacent sites.

These detail our approach to achieving the aspirations set out in the vision and objectives.



A number of sites that provide development opportunities in Fitzrovia are located adjacent to one another and so can best be considered together with the potential to achieve more comprehensive development schemes. This approach can optimise benefits for the area, such as more significant public open spaces and better pedestrian accessibility.

The working draft of the Area Action Plan includes masterplanning urban design work for the 'Bedford Passage' group of opportunity sites (Astor College, Middlesex Hospital Annex, Arthur Stanley House and Tottenham Mews Day Hospital) as an example of the approach we intend to take throughout the Plan, subject to the results of consultation and engagement on the working draft.





This indicative site layout shows how the design principles we have identified for this group of sites may be incorporated into a scheme. They develop a strategy for how the links, open space and massing of the buildings relate or may be related to each other. The final version of this will form a preferred strategy for the Council and act as a starting point for negotiation, but will not preclude alternative arrangements for this location that embody the broad principles set out in the Plan.

Fitzrovia is severely lacking in public open space, with only three publicly owned and accessible open spaces in the area. As part of the preparation work for the Plan, we commissioned an open space and public realm study to identify opportunities to increase publicly accessible open space. The results of the study have been fed in to the working draft of the Area Action Plan. Opportunities identified include:

- provision of public open space within development sites;
- improvements to existing open spaces;
- more effective use of highway space including the creation of a new public open space in Alfred Place by reducing road space.



What happens next?

The Council, working with the Steering Group, will consider the responses received during consultation and engagement on the working draft and amendments will be made to the Plan as required. Once the revised Plan is approved by the Council it will be made available for further comments later this year and then submitted to the government for public examination by a Planning Inspector. When approved by the Inspector and adopted by the Council we will used it when we made decisions on planning applications in Fitzrovia.
