We are writing to let you know that we are about to consult on ideas to make the Gospel Oak area (which includes parts of Gospel Oak and Haverstock wards) an even better place to live in, work in and visit. The consultation will run from **19 November – 22 January 2016**.

We aim to make improvements in Gospel Oak through a self-funded scheme called the Community Investment Programme. This means we need to build some private housing to pay for the other improvements. We might not be able to do everything you suggest, therefore we need to know what is important to you.


If you live in West Kentish Town or Wendling Estates we will be talking to you as part of a separate consultation.
