## Laystall Street

### Pedestrian and cycle access improvements

We are writing to inform you of the Council's proposal to improve pedestrian and cycling access in Laystall Street. This is in line with the council's goals of encouraging non-polluting forms of transport and healthier ways of getting about, particularly walking and cycling.

### Proposed changes

We are proposing to introduce measures that will restrict access to motor traffic on Laystall Street between Mount Pleasant and Rosebery Avenue. This would be carried out under an Experimental Traffic Order (ETO) in order to determine the level of impact on Mount Pleasant. It is proposed that the ETO will be in place for 6 months, with a separate consultation after this time should the decision be taken to make the measure permanent.


This measure will prevent the route from being used as a motor traffic cut through between Mount Pleasant and Rosebery Avenue, creating a more pleasant pedestrian environment and permitting safer access to the Christopher Hatton school. It will also allow two way cycle movement, which will complement the recently installed point closure at the southern end of Gough Street, to create a quiet North – South cycle route parallel to Gray's Inn Road.

Motor vehicles prohibited signs will be used at either end of the measure. Motor vehicle access to the school and to Mullen Tower will be maintained, with two way motor traffic permitted between the entrance to Mullen Tower and Mount Pleasant. A removable bollard located at the mid point on Laystall Street will provide a physical restriction to general traffic whilst maintaining refuse collection and emergency service access.

A loading point will be created on Mount Pleasant in place of an existing resident parking bay to replace the existing loading bay on Laystall Street, which will now be used as a passing place to allow the aforementioned two way traffic movement. The total loss of parking required to implement the scheme will therefore be one resident bay.

In addition to this, a 7.5t weight restriction will be implemented at the junction of Mount Pleasant and Elm Street in order to restrict access on Mount Pleasant to larger Heavy Goods Vehicles. No through road signage will be used at the junction of Mount Pleasant and Elm Street warning motorists that Laystall Street is no longer a through route.

The proposed measure is shown in the drawing below.

This report will be presented to the Director of Regeneration and Planning (Supporting Communities Directorate) who will make a decision whether or not to proceed with implementing the proposals.
