the EUSTON AREA PLAN

A new plan, called the Euston Area Plan, is being prepared for the area around Euston Station. This will help to shape change in the area up to 2031.

The plan is being jointly prepared by Camden Council, the Greater London Authority and Transport for London. It seeks to ensure that, whether or not the new High Speed rail link (HS2) goes ahead, despite Camden Council's strong opposition to HS2, we can get the best possible future for the residents, businesses and visitors to Euston.



There have been aspirations for redevelopment of the station for some time, and even if HS2 does not proceed the plan provides a framework for this and seeks to maximise the delivery of new homes, businesses, shops and associated education, leisure, open space and improved public realm focused around the station area.

Draft Euston Area Plan




