What Personal Data will we collect about you and for what purpose?

We are collecting feedback from residents and stakeholders for a green space improvement project on Phoenix Road in Somers Town. This is part of Camden's work to address the loss of open space resulting from the construction of High Speed 2.

We are collecting personal contact data so we can feedback to participants with the findings of the engagement and to keep them informed of project progress. Providing this information will be optional. We will also be sharing emails submitted to Camden council about this engagement directly with Groundwork London, who are carrying out the work on our behalf, including names and email addresses.

We are collecting some special category data (disability and ethnicity) to help us understand if we have been successful in reaching a wide range of residents and stakeholders and to identify underrepresented groups so we can consult them in future.

What is our legal basis for processing your data?

Our legal basis for processing personal data under the GDPR is Article 6(1)(e) public task, Article 9(2)(g) substantial public interest, Article 6(1)(a) consent and Article 9(2)(a) consent.

What categories of Personal Data are being processed?

- Name
- Email addresses
- Postcode (not full address)
- Age
- Gender
- Ethnicity
- Disability

Who will the council disclose your data to?

We will disclose the data to Groundwork London, who we have commissioned to undertake the engagement work.

<p>Will we transfer your data outside of the EU/EEA?</p> <p>We will not transfer your Personal Data outside the EU/EEA.</p>
<p>How long do we keep your personal data?</p> <p>We will retain personal data for the duration of the project so we can keep people updated on progress plus 2 years following its completion.</p>

<p>What information is mandatory for you to provide and what are the consequences of not providing the information?</p> <p>You do not have to provide your name, address or the special category data and if you don't we will still take your views into account.</p>
