The purpose of the processing:

The London Borough of Camden (LBC) is collecting contact information and equalities information as part of the consultation on early years nursery provision and a proposed new approach to early years investment in Camden through online questionnaire. This information will be used to understand the representation of consultation responses and analyse any potential subgroup differences.

The legal basis for processing: Our legal basis for processing under the General Data Protection Regulations is Article 6(1)(a)-Consent and Article 9(2)(1)-Consent

The Categories of Personal Data: Name, address, email, gender, age, ethnicity, disability, whether you have a child in a Camden nursery and age of child.

The categories of recipients that the council has or will disclose the data to:

The LBC will not share your personal information with a third party provider.

Your data will not be used for any other reason.

Whether the council will transfer their data out of the EU/EEA.

We will not transfer your Personal Data outside the EU/EEA.

The criteria used to decide the retention period

We will keep any data collected from the survey for 1 year.

Your Data Subject Rights

You have the right to request a copy of the information we hold about you, the right to ask us to rectify, erase or restrict processing of your data, the right to ask for data portability, the right to object to automated decision making, and if we are relying on consent the right to withdraw consent at any time. There are some exemptions to these rights.
