## **PUBLIC CONSULTATION**

# PROPOSAL: Wayfinding Scheme for Hampstead High Street using Legible London signage

We are writing to seek your views on the Council's proposal to place Legible London signs on Hampstead High Street. This will help pedestrians find their way between Hampstead underground station and Hampstead Heath and around the wider area.

Legible London is a Transport for London led signage that has become the London standard for clear mapping and directional information. Legible London signage has become part of the London's streetscape and has been used in key conservation areas such as Bloomsbury, Westminster and Kensington. In Camden we have installed these signs across the borough for the last eight years with areas including Fitzrovia, Covent Garden, Kings Cross, Belsize Park and Camden Town.

Hampstead is a key tourist destination in the borough and the aim of these signs would be to improve directional information for visitors and promote a wider scope of local attractions. Providing better signage supports Camden and London-wide policies to encourage walking, by providing clear mapping, walking distance information and destinations in the local area.

Below is an example of an existing fingerpost sign and a Legible London sign.

Please note only one existing fingerpost sign will be removed as part of this scheme, that sign is at the junction of Flask Walk and is one meter from sign 1 on the plan below).



#### **Proposal details**

We are consulting on placing four Legible London signs between Hampstead underground station and Downshire Hill. The locations are as follows –

- Sign 1 (Small) Hampstead High Street at the junction of Flask Walk
- Sign 2 (Medium) Outside 28a Hampstead High Street (Carphone Warehouse)
- Sign 3 (Medium) Outside 1 Hampstead High Street (Café Nero)
- Sign 4 (Medium) Outside 32-34 Rosslyn Hill (Carluccio's restaurant)

The above locations have been carefully assessed to ensure the signs are placed at key decision points for pedestrians and support the route along Hampstead High Street and onwards to the wider area. All locations have had an engineering assessment to check footway widths are sufficient to not restrict pedestrian movement.
