The purpose of the processing

To find out what topics young people would like to learn about at school in relation to 'life skills' and to find out what they think about living in the borough / what could be improved. Once feedback has been analysed to identify trends, social action campaigns to respond to what young people have told the Camden Youth Council (CYC) is important will be developed – CYC have been allocated a budget of £20,000 by the Council's Integrated Youth Support Service for this purpose.

The legal basis for processing

Article 6(1)(e) of the GDPR- "Necessary for the performance of task carried out in public interest or in exercise of official authority vested in controller" and Article 9(2)(g) "reasons of substantial public interest"

The Categories of Personal Data

First part of participants' postcodes, age, gender, sexuality, ethnicity, disability, email address (for receipt of a copy of your survey response or to contact you about a voucher only) – no questions are compulsory and there is a 'prefer not to say' option for all.

Whether the council will transfer their data out of the EU/EEA.

We will not transfer your Personal Data outside the EU/EEA.

The criteria used to decide the retention period

The data will be destroyed 6 months after completion of the project and will not be used for any other purpose.
